The class will provide a comprehensive review of the test outline and content highlights. *Target audience - interpreters who are at the beginning or mid phase of test preparation.*

2:00 – 5:30 p.m. Participants are expected to have background knowledge of content and study materials. This class will provide an overview of test questions and discussion of test taking strategies. This will be an open forum format with an opportunity for questions from attendees regarding specific material they want clarified. *Target audience - interpreters taking the written test within a few months.*
